

#### **MAINTAINING YOUR**

Vunyx<sup>®</sup> Paint Protection Film


- 1 >> Avoid Touching After Installation: After installation, allow the protection film to settle and cure for at least 72 hours. During this period, refrain from touching the film, even if you notice some initial bubbling. It should disappear once the curing process is complete. Note that low temperatures and high humidity might extend the curing time.
- 2 >> Post-Installation Washing: While the film is settling and curing, it's best to avoid washing your car or driving it whenever possible. If driving is unavoidable, take care not to apply pressure on the film to prevent any settling issues.
- **3** >> Mindful Cleaning Practices: After film installation, it's advisable to forego commercial car washes for the sake of your film's longevity. Instead:
  - Use car wash soap with a clean microfiber mitt.
  - Soak stubborn spots in soap for several minutes.
  - For tough spots, consider using 99% isopropyl alcohol.
  - Dry the film using a microfiber towel.

Avoid using brushes, terry cloth, or paper products, as they can dull or damage the film. Promptly remove dead bugs, bird droppings, and dirt droppings to prevent permanent stains, paying particular attention to the film's edges. Never use abrasive materials.

4 >> Invest in Quality Cleaning Products: Opt for high-quality car wash soap without harsh chemicals that could harm the film. Ensure your microfiber mitt is designed for auto care. If you choose to wax the film, make sure it's free of Naphtha or Kerosene with a concentration of over 5% and avoid waxes with dyes. Onyx Coating GmbH offers its own maintenance products, but top-notch car maintenance soaps, shampoos, and wax can also do an excellent job.

Additionally, apply Onyx Coating PPF Ceramic Boost at least once every 6 to 12 months to preserve the high gloss. Minor scratches on the film will selfheal in 20-30 minutes at room temperature, or you can accelerate the process by pouring warm water (120°F) over the affected area. Be cautious not to use a pressure washer or high-pressure water near the film's edges, as it can cause lifting or damage. You can use Detailing Clay to remove contaminants from the film.

#### **ANNUAL INSPECTIONS**

To uphold your product's warranty, an annual inspection is mandatory during the warranty period, as outlined in the product specifications. These inspections should be conducted by an ONYX COATING certified installer each year and completed within 10 days before or after the installation anniversary date or the date of any previous inspection or service. Failure to meet this requirement will void the Limited Warranty. Any charges incurred by the ONYX COATING GMBH Certified Installer for the annual inspection, including exterior wash, decontamination, and inspection, will be the owner's responsibility. #### WARRANTY TERMS AND CONDITIONS

for Vunyx<sup>®</sup> Paint Protection Film

Onyx Coating GmbH (referred to as "the Company") hereby provides an explicit warranty to the vehicle owner that, for a specified period (see Durability below) from the initial installation date (referred to as the "Warranty Period"), the following products will be covered:

This warranty from the Company covers manufacturer defects found in Vunyx<sup>®</sup> paint protection films, including issues such as yellowing, cracking, blistering, delamination, or adhesive failure. Please note that this Limited Warranty only applies to Vunyx<sup>®</sup> paint protection films installed in accordance with the guidelines recommended by Onyx Coating GmbH.



If a manufacturing defect is solely responsible for the failure or inadequate performance of the Product within the Warranty Period, Onyx Coating GmbH will, at its discretion, either remove or replace the Product without any charges. If replacement is chosen, an authorized installer selected by Onyx Coating GmbH will carry out the removal and reapplication of the Product to areas determined by Onyx Coating GmbH at its sole discretion to be covered by this Limited Warranty. The Company will cover both parts and labor. Replacement of the defective film constitutes the exclusive remedy for all Products covered under this Limited Warranty.



Throughout the entire Warranty Period, Onyx Coating GmbH's obligation to repair or replace is further limited to the repair or replacement of only the specific Product suffering from a manufacturing defect. Any repaired or replaced Product will remain subject to the original Warranty Period and will not extend it or initiate a new warranty period. ### HOW TO FILE A WARRANTY CLAIM

ONYX Coating GmbH retains the right to validate eligibility for warranty coverage and inspect the affected installation before approving a claim. All approved warranty service claims must be directed to the independent dealer authorized by ONYX Coating GmbH or Official Distributors to perform such service, following the terms outlined in this document.

ONYX Coating GmbH or Official Distributors also reserves the right to approve the independent dealer conducting the warranty service. To initiate a warranty service claim, adhere to these steps:

- 1 >>> Contact your original installing dealer to initiate a warranty service claim. If youroriginal installing dealer is unavailable, please reach out to the Warranty Service Department at ONYX COATING GmbH | Hardenbergstr. 12 | 10623 Berlin, or send an email to info@onyxcoating.com, or call +49 308 878 9772.
- **7 >>>** To process a warranty claim, the following documentation is required:

**A.** Original warranty certificate or the detailed information contained within it.

**B.** Proof of purchase from the installing dealer, ideally retained by attach ing a copy of your original invoice/receipt to your original ONYX Coating warranty certificate.

- **3 >>** The authorized warranty repair service provider must submit these documents to ONYX Coating GmbH and obtain written pre-approval before commencing the warranty repair service.
- **4** >>> Upon completion of the warranty repair service, the customer will be asked to sign a warranty repair claim form. This form facilitates reimbursement for the warranty repair service to the dealer.
- **5** Mll warranty claim payments will be directed to the authorized warranty repair service provider who received prior approval from ONYX Coating GmbH, in conjunction with Official Distributors, to perform the warranty service, according to the terms of this warranty.
- 6 >>> All warranty claim payments will be directed to the authorized warranty repair service provider who received prior approval from ONYX Coating GmbH, in conjunction with Official Distributors, to perform the warranty service, according to the terms of this warranty.

- 2 >>> Incorrect storage, installation, handling, and/or use of the Product.
- **3 >>** Damage not resulting from manufacturing defects that occur while the Product is in the customer's possession.
- **4 >>** Unreasonable or unintended Product use.

- 9 >>> Damage resulting from collision, accidental damage, vandalism, fire, hail, flood, surface rust, rail dust, physical damage, paint overspray, or paint manufacturer defects (may be covered under a manufacturer's protection plan).
- **10 >>** Non-automotive applications.
- 11 >>> Use of non-onyx coating branded ceramic coatings.
- 12 Damage caused by external forces, such as the physical impact of rocks or road debris.
